2026 Municipal Election – Updated Ward Boundaries & Voting Locations

The Municipality of Two Borders has updated its ward boundaries. These changes will be in effect for the **2026 Municipal Election held on Wednesday, October 28, 2026.**

Residents are encouraged to review the Voters List during regular office hours to confirm their new ward designation and ensure they know where to vote on Election Day.

Voting Locations for the 2026 Municipal Election

Wards 1, 2 & 3

Voting will take place at the
Pierson Municipal Office at 64 Railway Ave.

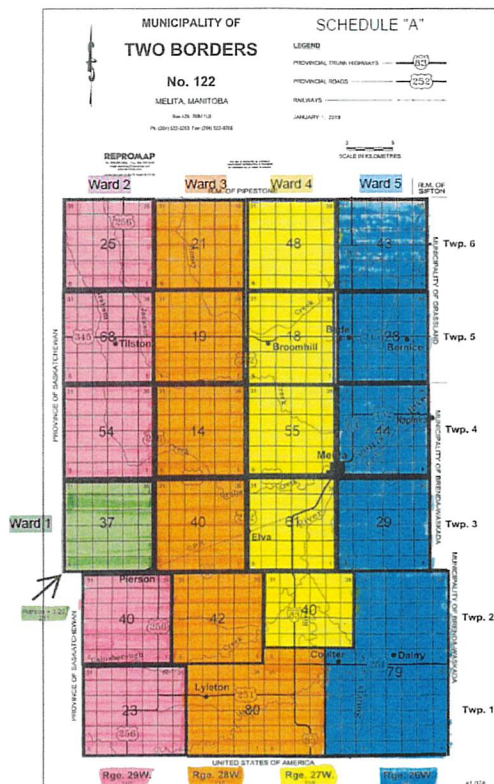
Wards 4 & 5

Voting will take place at the
Melita Municipal Office at 138 Main St.

Please check the Voters List in advance so you are prepared for Election Day.

Ward boundaries are used for election purposes. Once elected, all members of Council represent the Municipality of Two Borders as a whole.

MUNICIPALITY OF TWO BORDERS

BY-LAW NO. 128/2025

Being a By-Law of the Municipality of Two Borders to establish a new ward system for the purpose of electing municipal councillors.

WHEREAS subsection 87(1) of The Municipal Act provides as follows:

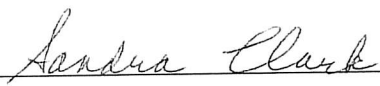
“Every member of a council is to be elected by a vote of the electors of the whole municipality unless the council by by-law provides that the councillors are to be elected on the basis of wards”.

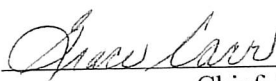
AND WHEREAS it is deemed necessary and desirable to establish a new ward system to elect municipal councillors;

NOW THEREFORE, the Council of The Municipality of Two Borders enacts as follows:

1. **THAT** the Municipality be divided into five (5) wards, as per attached Schedule “A”
2. **THAT** the five (5) wards be named as follows:
 - a. Ward 1: Comprising Sections 1-36 of Township 3 in Range 29 (including the Community of Pierson). One (1) councillor shall be elected from among the nominations received for this ward.
 - b. Ward 2: Comprising Sections 6-7, 18-19, 30-31 of Township 1 in Range 28; and Townships 1-2 and 4-6 in Range 29. One (1) councillor shall be elected from among the nominations received for this ward.
 - c. Ward 3: Comprising Sections 3-10, 15-22, 27-34 of Township 1 in Range 27; Sections 3-6 of Township 2 in Range 27; Sections 1-5, 8-12, 13-17, 20-29, 32-36 of Township 1 in Range 28; and Townships 2-6 in Range 28 (excluding the Community of Pierson). One (1) councillor shall be elected from among the nominations received for this ward.
 - d. Ward 4: Comprising Sections 7-36 of Township 2 in Range 27; and Townships 3-6 in Range 27 (excluding the Town of Melita). One (1) councillor shall be elected from among the nominations received for this ward.
 - e. Ward 5: Comprising Townships 1-6 in Range 26 (excluding the Town of Melita); Sections 1-2, 11-14, 23-26, 35-36 of Township 1 in Range 27; and Sections 1-2 of Township 2 in Range 27. One (1) councillor shall be elected from among the nominations received for this ward.
3. **THAT** this by-law shall take effect at the next general election.
4. **THAT** By-Law No. 32/2018 is hereby repealed.
